# CALL FOR EXPRESSION OF INTEREST FROM AN INDEPENDENT FINANCIAL AUDIT FIRM TO CONDUCT SINGLE AUDIT OF FORUM-ASIA, ON BEHALF OF I4C-EA, FOR THE YEAR 2022

#### **Introduction**

The Asian Forum for Human Rights and Development (FORUM-ASIA) is a network of 82 member organizations across 23 countries, mainly in Asia. Founded in 1991, FORUM-ASIA works to strengthen movements for human rights and sustainable development through research, advocacy, capacity development and solidarity actions in Asia and beyond. It has consultative status with the United Nations Economic and Social Council, and a consultative relationship with the ASEAN Intergovernmental Commission on Human Rights.

The FORUM-ASIA Secretariat is based in Bangkok, with offices in Jakarta, Geneva, and Kathmandu. FORUM-ASIA is committed to building a peaceful, just, equitable, and sustainable community of peoples and societies in Asia, where all human rights of all individuals, groups and peoples, without discrimination on any grounds, are fully realized in accordance with international human rights standards and norms. It does so by:

- Building the capacity of its members and partners
- Bringing together activists and stakeholders to tackle human rights issues
- Protecting human rights defenders in Asia that find themselves in emergency situations
- Advocating for human rights at the national, regional, and international level

Innovation for Change — East Asia (I4C - EA) is one of seven regional innovation hubs worldwide, curated at the global level by the CIVICUS World Alliance, with the support of a multi-donor consortium. I4C-EA is hosted by the FORUM-ASIA and is the legal holder of I4C-EA grants that will be the subject of this audit.

I4C - EA's mission is to provide virtual and real spaces for civil society to co-design and innovate ideas and projects, and to jointly offer services and activities towards improving the lives of citizens and communities, and strengthening citizen's engagement and accountable governance, by defending, expanding and creating civic space in East Asia.

I4C – EA hub is led by an East Asia Governance Circle currently composed of 5 civil society individuals and organizations from Indonesia, Malaysia, the Philippines, and South Korea. The Hub is represented by two East Asia Stewards at the I4C Global Governance Circle. The Asian Forum for Human Rights and Development (FORUM-ASIA), based in Thailand, and the Asia Democracy Network (ADN) based in South Korea, are the East Asia Hub hosts and legal holders of the Hub's project grants, while providing administrative and financial support services to the Hub.

#### **Objective / Project Background**

FORUM-ASIA, on behalf of I4C – EA, is a recipient of USAID award of cost-reimbursement contracts through TIDES Centre.

FORUM-ASIA, on behalf of I4C – EA, as a non-Federal entity having spent more than \$750,000 during the FY 2022 in Federal awards is required to complete a single audit for that year in accordance with the USAID Financial Audit Guide for Foreign Organizations <u>ADS 591maa</u>, <u>USAID Financial Audit</u> <u>Guidelines</u>) and consistent with the provisions of <u>2 CFR Part 200</u>, <u>Subpart F</u>.

The audit must be conducted in accordance with the US GAGAS - Generally Accepted Government Auditing Standards. The independent auditor must determine whether the financial statements of FORUM-ASIA, on behalf of I4C – EA, are presented fairly in all material respects in accordance with U.S. generally accepted accounting principles (U.S. GAAP), or International Financial Reporting Standards (IFRSs), or International Public Sector Accounting Standards (IPSAS).

The audit should cover the transactions for FY 2022 associated with the following project grants with a total disbursement of about USD Nine Hundred Fifteen Thousand.
